Promise to pay. You will receive and invoice for each purchase you make using your account. You agree to pay the entire amount of each purchase order according to the terms of the billing invoice by the payment due date as stated on the invoice. You agree to pay in U.S. dollars for all purchases incurred by you.

You agree that Western Sling Company retains ownership of all material not paid for. You also agree that, if necessary, Western Sling Company has the right to file any documents required to assure our security interest in the material purchased.

If you change your address, you MUST notify us of this change within 10 (ten) working days. If there is a change of ownership or control of the company, you agree to notify us within 10 (ten) working days by overnight letter or registered letter.

1. We will not accept any form of payment which contains any limitations or conditions on payment such as short paid checks noted as representing payment in full of a disputed balance.

Line of Credit: Your line of credit may increase or decrease from time to time. Such changes will be made at the sole discretion of Western Sling Company, and no advance notification is promised or implied.

If your account is past due, orders may be held at Western Sling Companies sole discretion, and no advance notification is promised or implied.

Western Sling and Supply Company reserves the right to asses a service charge of 1-1/2% on all outstanding balances.

2. Collection related issues: If Western Sling Company must refer your delinquent account to an attorney, you agree to pay all reasonable attorney fees, court costs and other collection costs in connection with Western Sling Companies collection efforts.

- 3 .Returned Check Charges: A \$25.00 charge will be assessed on returned items which you agree to pay.

4. Privacy: By signing this application you agree to allow Western Sling Company to verify your credit references, and instruct these references to provide reasonable assistance and information to Western Sling Company.

5. Assignment: You understand that Western Sling Company may sell, assign, or transfer its rights to your account, or any portion thereof, without prior notice.

6. Jury Trial: You hereby waive the right to a jury trial in any action to collect amounts owed on your open account.

7. Jurisdiction: You agree that any legal action arising between Western Sling Company and you must be brought in the courts of the State of Colorado, Douglas County, and that you agree to submit all claims to the jurisdiction of these courts regardless of any conflict of jurisdiction which may arise.
